- I agree to give credit to the Archives, California Institute of Technology, whenever material from the Archives is quoted, summarized, reproduced or otherwise used in a publication.
- I agree to notify the Caltech Archives of any publications resulting from my work in Caltech's collections.
- If I arrange for an on-site visit to the Caltech Archives, I agree to comply with the Archives' [Reading Room Rules](#) and to conduct myself in a manner appropriate to a special collections environment.
- I understand and agree that a breach of any of the above conditions, and any other reasonable conditions that may be set forth by the Archives, may result in consequences including the removal or retraction of any publication resulting from use of the Archives' collections and the denial of access to the Archives' collections in the future.
